- 1. The careers.govt.nz website is hosted by us.
- We have received an application from you to use the content from the job profile section of the careers.govt.nz website, which includes information about more than 400 careers ("TEC Content"), through an application program interface ("API") owned by us.
- 3. By signing this Agreement you agree to be bound by the terms and conditions in this Agreement and the privacy statement on our website when accessing and using the API and the TEC Content.

Terms and conditions

- 4. As a registered user of our API, you:
 - (a) acknowledge that:
 - (i) we have granted you a non-exclusive, non-transferable, non-sub-licensable, royalty-free licence to use the TEC Content; and
 - (ii) we have not transferred any ownership rights in the TEC Content to you, and we reserve all rights not expressly granted;
 - (b) must ensure that all TEC Content has an acknowledgement that the TEC or careers.govt.nz is the source of the information;
 - (c) must only use the information for the purpose stated in your application;
 - (d) agree that we may audit your use of the API and the TEC Content;
 - (e) must provide us with the information we may request relating to your use of the TEC Content and the API;
 - (f) must ensure that you have the correct hardware and software required for the API, and update that hardware and software as required;
 - (g) must notify us immediately if you become aware that:
